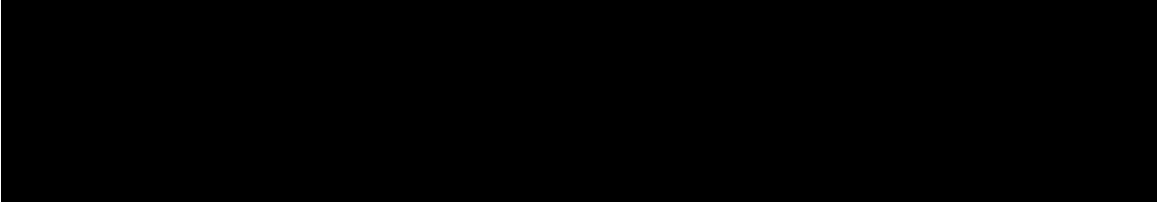

### **18. Protection of privacy**

#### **Section 739 Protection of privacy**

#### **PRIVACY AND PERSONAL INFORMATION PROTECTION ACT 1998**

#### **Section 58 Suppression of personal information**

**(1) A person about whom personal information is contained (or proposed to be contained) in a public register may request the public sector agency responsible for keeping the register to have the information:**

- (a) removed from, or not placed on, the register as publicly available, and**
- (b) not disclosed to the public.**

**(2) If the public sector agency is satisfied that the safety or well-being of any person would be affected by not suppressing the personal information as requested, the agency must suppress the information in accordance with**

**the request unless the agency is of the opinion that the public interest in maintaining public access to the information outweighs any individual interest in suppressing the information.**

**(3) Any information that is removed from, or not placed on, a public register under this section may be kept on the register for other purposes.**
