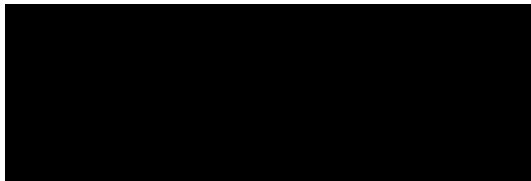

Section 58 Suppression of personal information
